**RE: GENERAL CHAIRPERSON NOMINATIONS & ELECTIONS  
2015**

Elections will be held this fall for twelve (12) General Chairpersons. The elections are to take place on Thursday, November 12, 2015. The term of office for those elected will be from January 1, 2016 through December 31, 2019.

As per Article 11.03 of the Transportation District 140 Bylaws, nominations for candidates will take place at the regular Local Lodge meeting during the month of September 2015.

Locals within each Region may nominate candidates for positions in their Region. The following nominations will be accepted from Locals within their Regions:

### **Eastern Region:**

- One (1) Air Canada designated General Chairperson
- One (1) Service designated General Chairperson
- One (1) Atlantic Canada General Chairperson

### **Central Region:**

- One (1) Air Canada designated General Chairperson
- One (1) Service designated General Chairperson
- Two (2) At Large General Chairpersons

### **Western Region:**

- One (1) Air Canada designated General Chairperson
- One (1) Service designated General Chairperson
- Three (3) At Large General Chairpersons

These positions shall be elected from and by these groups within their Region:

**Air Canada** – All Air Canada members (except those members working in Atlantic Canada)

**Service** – All Service Group members (except those members working in Atlantic Canada)

**At Large** – All IAMAW District 140 members (both Air Canada and Service)

**Atlantic Canada** – All Air Canada and Service members in Atlantic Canada

Article 11.03.01 states: *“Within twenty (20) days of the Local Lodge meeting where nomination(s) were closed, the accepted nominee must deliver to the District ST a letter signed and bearing the LL seal by his or her Local Lodge Recording Secretary, stating that the nominee meets the eligibility requirements of this Article. In addition, the nominee must submit a signed letter stating their acceptance of the nomination”.* Further, as per Article 11.07.05: *“Candidates may only declare and accept nomination for one (1) position.”*
