Dear Sisters and Brothers,

Our most recent Collective Bargaining Agreement was finalized by arbitration and the award was issued on August 26, 2021.

Your Negotiations Committee had tried on multiple occasions to meet with the Company to do a final review and sign the agreement. Unfortunately, a dispute arose, and the Company refused to sign the agreement.

After months of delay back and forth, the signing of the CBA was brought back to Arbitrator Keller for final determination. On March 14, 2022, the Company was ordered to sign the CBA.
